Enrollment in Families of Faith Christian Academy is the choice of enrolling in a private school instead of becoming a county homeschooler. While most of our families complete their academics at home (much like a homeschooler), Families of Faith is required by state laws to maintain certain required student's records, both permanent and temporary. By statute, we must have the student's full, legal name (as listed on the official state birth certificate), date of birth, etc. The student's Social Security Number is required for college-bound transcripts. No government agency has access to these records, with the exception of:

- 1) Review of health records by the county health department.
- 2) Verification of attendance by the superintendent's appointee.
- 3) Transcripts transferred to another school or college at the family's request.
